

## **REPORT - 13th Arab-Austrian Economic Forum & Exhibition:**

## High-level minister attendance and future technologies at the 13<sup>th</sup> Arab-Austrian Economic Forum

27 November 2023 – Vienna, Austria



Inspiring technological innovations and business potentials with Arab countries were presented at the **13th Arab-Austrian Economic Forum**, which was held on November 27, 2023 at the Haus der Wiener Wirtschaft in Vienna with over 200 participants attending.

The Forum was organized by the **Austro-Arab Chamber of Commerce** (AACC) and the **Vienna Chamber of Commerce** (WKW), in cooperation with official institutions, diplomatic missions of Arab countries and international organizations, and focused on energy strategies and economic cooperation with Arab countries.
